

MAINPRIZE REGIONAL PARK BYLAW NO. 03 – 2017

A Bylaw respecting the operation of Golf (Power) Carts and All Terrain Vehicles within the boundaries of Mainprize Regional Park.

This Bylaw may be cited as the “Golf Cart and the “All Terrain Vehicle” Bylaw.

The Mainprize Regional Park Authority, in the Province of Saskatchewan enacts as follows:

1. INTERPRETATION

- a) Golf cart shall mean a small motorized vehicle that can transport the same number of people as it has manufactured seats and has no seatbelts.**
- b) An All Terrain Vehicle is any self propelled vehicle that is designed primarily for the movement of people or goods on unprepared surfaces and has wheels in contact with the ground. In Mainprize Regional Park this includes quads and side by sides. Dirt bikes / trail bikes are not allowed in the Park.**
- c) Designated roads mean:**
 - i) The main road through the Park, beginning at the Park entry gate through to the maintenance building and from the maintenance building out past the hobby shops to the TP. 5 pavement.**
 - ii) The road through Harbour View Drive Subdivision.**
 - iii) The campground road including all accesses to areas “A” up to “K”.**
 - iv) All access roads to the golf course, beach, boat launch area, rental cabins, Bed and Breakfast and Woody’s Flying Field.**

2. GOLF CARTS

- a) Golf carts transported to and from the golf course and used ONLY on the golf course (including Mainprize Golf Club carts) are exempt.**
- b) It shall be lawful to operate a golf cart between the hours of 6:00 am and 11:00 pm on all designated roadways and trails within the limits of the Park and under control of the Park Authority.**
- c) The number of people allowed on a golf cart at one time cannot exceed the number of factory installed seats. One person per seat is the maximum.**
- d) All power carts must be registered with the Park (\$10.00 per plate & \$25.00 annually for a sticker).**
- e) All personal and public liability will be the responsibility of the owner / operator of the said cart. The owner of the golf cart must insure themselves and every other person who, with the owner’s consent, operates that golf cart against liability imposed by law arising out of the ownership and use or operation of that golf cart. Proof of insurance will be required at time of registration and at the request of a Peace Officer, Park Officer or Police Officer.**
- f) The operator of a golf cart must be 16 years old with a valid driver’s license.**
- g) The golf cart shall not be operated by any person under the influence of intoxicants, narcotics or other substance abuse products.**

h) Any person who contravenes any portion of this Bylaw is guilty of an offence and liable on Summary Conviction to a fine of not less than \$100.00 or more than \$500.00.

3. ALL TERRAIN VEHICLES (ATV)

a) It shall be lawful to operate an ATV between the hours of 6:00 am and 11:00 pm on all designated roadways and trails within the limits of the Park and under the control of the Mainprize Regional Park Authority. Operation of an ATV after 11:00 pm quiet time is prohibited.

b) While operating an all terrain vehicle, it is unlawful to transport more passengers than there are factory installed seats.

c) All ATV's must be registered with the Park (\$10.00 per plate & \$25.00 annually for a sticker).

d) All personal and public liability will be the responsibility of the owner / operator of the said ATV. The owner of the ATV must insure themselves and every other person who, with the owner's consent, operates that ATV against liability imposed by law arising out of the ownership and use or operation of that ATV.

e) Proof of insurance will be required at the time of registration and at the request of a Peace Officer, Park Officer or Police Officer.

f) The operator of all ATV's must be a minimum of 16 years old and carry a valid drivers license.

g) An ATV shall not be operated by any person under the influence of intoxicants, narcotics or other substance abuse products.

h) The operator and any passenger in or on an ATV that is being operated shall wear a helmet and protection for the eyes.

i) ATV's must be operated within the Park's posted speed limits.

i) Any person who contravenes any portion of this Bylaw is guilty of an offence and liable on Summary Conviction of a fine of not less than \$100.00 or more than \$500.00.

This Bylaw shall come into force on the date of the final reading and adoption of this Bylaw.

MAINPRIZE REGIONAL PARK

GOLF / POWER CART REGISTRATION

- > A golf cart registration authorizes the operation of a golf cart on roadways and trails properly designated by the Mainprize Regional Park Authority (MRPA). It is the responsibility of the golf cart owner to know what roadways and trails are permissible for the operation of a golf cart.
- > The owner of the golf cart must have appropriate third party liability insurance covering the cart and state the same to the MRPA. Liability insurance must be continuously maintained in the name of the owner of the golf cart for the entire time the golf cart is registered or should be registered with the MRPA.
- > It is the responsibility of the owner of the golf cart to maintain it in safe and proper working order.
- > The operator must comply with the Saskatchewan Vehicle Safety Act.

Fees

- > The fee for golf car registration is \$12.00 per plate all taxes included & \$25.00 annually for a sticker. The registration expires on May 15th annually.
- > The registration number sign provided to the owner of the golf cart shall be affixed to the rear of the golf cart in a manner as to be visible at all times.

Conditions

- > The applicant agrees that the golf cart shall NOT under any circumstances be used by any person:
 - * Under the age of 16 years;
 - * Without a valid or non – restrictive drivers license;
 - * Under the influence of intoxicants, narcotics or substance abuse;
 - * In any willing & wanton abusive, reckless or unlawful manner;
 - * With more than THE APPROVED NUMBER OF RIDERS (one person per seat);
 - * In any race or contest.

LIABILITY INSURANCE

ATV REGISTRATION (QUADS OR SIDE BY SIDES)

- > An ATV registration authorizes the operation of an ATV on roadways and trails properly designated by the Mainprize Regional Park Authority (MRPA). It is the responsibility of the ATV owner to know what roadways and trails are permissible for the operation of an ATV.
- > The owner of the ATV must have appropriate third party liability insurance covering the ATV and state the same to the MRPA. Liability insurance must be continuously maintained in the name of the owner of the ATV for the entire time the ATV is registered or should be registered with the MRPA.
- > It is the responsibility of the owner of the ATV to maintain it in safe and proper working order.
- > The operator of the ATV must comply with the Saskatchewan Vehicle Safety Act and the Saskatchewan All Terrain Vehicles Act.

Fees

- > The fee for the ATV registration is \$12.00 per plate all taxes included & \$25.00 annually for a sticker. The registration expires on May 15th annually.
- > The registration number sign provided to the owner of the ATV shall be affixed to the rear luggage bar in a manner as to be visible at all times.

Conditions

- > The applicant agrees that the ATV shall NOT under any circumstances be used by any person:
 - * Under the age of 16 years;
 - * Without a valid or non – restrictive drivers license;
 - * Under the influence of intoxicants, narcotics or substance abuse;
 - * In any willing & wanton abusive, reckless or unlawful manner;
 - * With more than THE APPROVED NUMBER OF RIDERS (one person per seat);
 - * Without a helmet and eye protection.
